The regular General Assembly of the SCSC was called to order on March the 18th, 2010 in Saas Almagell by Dr Roland Noirat, SCSC president

1. President report (Dr Roland Noirat)

- 1.1. Approval of the minutes of the 2007 GA assembly, unanimously accepted.
- 1.2. Since the very first SCSC event, which was with the Conformable company, most of those activities took place in the French part of Switzerland. The president would like to have some gathering in the eastern part of the country. The 2009 event were:
 - 1.2.1. Beach Volley in Lausanne
 - 1.2.2. Athletissima
 - 1.2.3. Lausanne Marathon.
- 1.3. Chiropractors at sport events:
 - 1.3.1. 37 DC took part in the World Games in Taiwan
 - 1.3.2. 175 DC took part in the Olympics in Vancouver.
 - 1.3.2.1. For the first time a chiropractor, at all time, was at work in the polyclinic.
- 1.4. FICS in awaiting a contract with the Combat Games in Beijing in 2010.
